

Our Commitment To Your Privacy

What Information Is Collected:

As part of the order process, the following information is collected from shoppers:

How That Information Is Used:

Our Commitment To The Security of Your Data

Because we gather certain types of information about our users, we feel you should fully understand the terms and conditions surrounding the capture and use of that information. This Privacy Policy discloses what information we gather and how we use it.

Collection of Information

If you purchase a product from us, we will request certain personally identifiable information from you on our order form. You must provide contact information (such as name, email and shipping address) and financial information (such as credit card number and expiration date) that we can use for billing purposes and to fill your orders.

We will use your personally identifiable information to process your orders and applications and to generally manage our site. In addition, we will use your personally identifiable information to communicate with you in response to your inquiries, to provide the services you request, and to manage your account. We may send you information on promotions and we will send you service-related announcements when it is necessary to do so.

We may use third parties to fulfill orders, to process credit card transactions, to help us analyze our website and to assist us in marketing, and we will share personally identifiable information as necessary for the third parties to provide those services. We reserve the right to disclose your personally identifiable information as required by law and when we believe that disclosure is necessary to protect our rights and/or to comply with a judicial proceeding, court order, or legal process.

Children

We will never knowingly request personally identifiable information from anyone under the age of 13 without requesting parental consent.

Links to Other Sites
